The polls will open at 6:00 a.m. and close at 7:00 p.m. The purpose of the election is to permit the qualified electors of the District to vote on authorizing the District to adopt a General Maintenance and Operation Budget in an amount that includes up to 10% in excess of the revenue control limit for the 2010-2011 fiscal year and for six subsequent years (subject to certain reductions provided by statute in years 6 and 7). The District's existing budget override has by law been reduced by one-third in the current fiscal year and is by law required to be reduced by an additional one-third in the next fiscal year. Because of these reductions, the proposed Maintenance and Operation budget will exceed the District's 2010-2011 alternate budget in an amount of approximately \$11,042,540 and the estimated secondary tax rate required to fund this amount is \$0.23 per \$100 of secondary assessed valuation. The total budget override amount for the first year of the new override is estimated to be \$16,563,810 and would be funded in that year by an estimated tax rate of \$0.3463 per \$100 of secondary assessed valuation, which is approximately \$0.12 more than the 2008-2009 tax rate for the existing override. In future years the amount of the increase will be as provided by law.
